## Short Rounds

AUGUSTA, GA - A U.S. Marine reservist collecting toys for children was stabbed when he helped stop a suspected shoplifter in eastern Georgia. Best Buy sales manager Orvin Smith told The Augusta Chronicle that the man was seen on surveillance cameras Friday putting a laptop under his jacket at the Augusta store.

When confronted, the man became irate, knocked down an employee, pulled a knife and ran toward the door. Outside were four Marines collecting for the Toys for Tots program.

Smith said the Marines stopped the man, but he stabbed one of them, Cpl Phillip Duggan, in the back. The cut did not appear to be severe.

The suspect, whose name was not released, was held until police arrived. The Richmond County Sheriff's office said it is investigating.

The suspect was transported to the local hospital with two broken arms, a broken leg, possible broken ribs, multiple contusions and assorted lacerations including a broken nose and jaw...injuries he sustained when he FELL trying to run after stabbing the Marine.

### "DON'T LOCK YOUR KEYS IN YOUR WALL LOCKER"

This once in a lifetime event occurred on March 12, 1962 at Officer's Candidate School in beautiful Quantico. Virginia. All League members who are Officers know Quantico very well.

I was a member of the 30th Officer Candidate Class and was raring and ready to go. The first day was going fairly well with the DIs gently (BS) introducing 42 gung ho and unaware and unprepared civilians to our wonderful Corps. Obviously, they kept us on the move all day going through Candidate Processing; medical screening; designer haircuts; uniform issue; rifle & 782 gear; chow hall with its culinary delicacies, barracks assignment, squad bay, and rack assignments.

Other than the continuous barrage from our DIs, everything was going well, if shell-shocked can be considered well. The DIs had an uncanny ability to see and hear everything and we dropped and did push-ups until we thought we were part of the squad bay deck.

I don't want to bore you guys any further so let me proceed to the reason for the title of this Sea Story.

The DIs had us all lined up in front of our racks nattily attired in our white skivvy shirts with matching boxer shorts that came down to our knees. They then had us play games with our rifles and when the fun was over, I put my rifle in my locker and proceeded to secure my locker and it only took me 5 seconds to realize that I had locked my keys in the wall locker! Obviously, I had to inform my DI what I had done. That's when the fun really began for the other 41 candidates and terror began for one skinny candidate as both DIs descended on me and proceeded to berate me and I can't use the language because "Ladies" will be readying this classic. The Senior DI informed me that I would have to go to the first deck and get the bolt cutters from the 1stSgt's Office.

Unfortunately, we were the last platoon of four to be put to bed so when I arrived at the 1stSat's Office nattily attired in my skivvy uniform, there were 6 other DIs plus the 1stSgt in the company office. After they made me try to knock the Hatch down by saying "I Can't Hear You" they ordered me into the Office and asked why I was there interrupting their "important" business. When I told them about the locked keys, all the DIs went crazy. They each took turns telling me what a puke I was and they were glad I wasn't in their platoon. Finally, after what seemed an eternity of verbal abuse, the 1stSgt said they lost a candidate in the last class because he locked himself in the locker and they didn't find him for 3 days (joking, I think). He asked me if I wanted that to happen to me. Of course, I said no, and he finally gave me the bolt cutters, which were almost as tall as I was. He said get out of here and I want those cutters back in 3 minutes or less. Needless to say, I proceeded to my 2nd deck squad bay and cut the lock and returned the cutters with 30 seconds to spare. The 1stSgt said get out of his office and that he and the other DIs would be watching me during the next 11 weeks.

I remembered the advice that my Officer Selection Officer gave me during the recruiting process - "Stay Off the Skyline" and you will be alright. Obviously, I wish I would have remembered that advice before I locked the keys in my locker.

This Sea Story has a happy ending because I stayed off the skyline and was commissioned on May 25th 1962 and lived happily ever after.

## This Month in History

**10 Jan 1995:** The Pentagon announced that 2600 U.S. Marines would be deployed to Somalia for Operation Unified Shield to assist in the final withdrawal of UN peacekeeping troops from Somalia.

**16 Jan 1991:** Operation Desert Shield became Operation Desert Storm as forces of the allied coalition launched an all-out air campaign against targets in Iraq and occupied Kuwait in an effort to liberate Kuwait. **18 Jan 1951:** Marines of the 1st Marine Division began mopping-up operations against guerrillas in the Pohang areas, South Korea following the Division's return from its epic battle with Communist Chinese troops at the Chosin Reservoir.

20 Jan 1968: The second battle for Khe Sanh began when Marines from the 3rdBattalion, 26th Marines attacked a North Vietnamese battalion between Hill 881 South and Hill 881 North. More than 100 of the enemy were killed. 22 Jan 1969: Operation Dewey Canyon, perhaps the most successful highmobility regimental-size action of the Vietnam War, began in the A Shau/Da Krong Valleys when the 9th Marines, commanded by Colonel Robert H. Barrow were lifted from Quang Tri. By 18 March the enemy's base area had been cleared out, 1617 enemy dead had been counted and more than 500 tons of weapons and ammunition unearthed. 25 Jan 1856: Marines and seamen from the U.S. sloop DECATUR went ashore at the village of Seattle, Washington to protect settlers from Indian raids. The Indians launched a seven-hour attack but were driven off later that day after suffering severe losses. Incredibly, only two civilian volunteers were killed and no Marines or sailors were lost. 29 Jan 1991: The first serious ground fighting of Operation Desert Storm broke out when Iraqi troops mounted an attack

The Marine Corps implemented a new qualification system for the combat water survival training that went into effect for all Marines Nov 10. The new system focuses on safety and effectiveness while reforming qualification requirements.

into Saudi Arabia along a 40-mile front.

"Marines are inherently amphibious by nature and are expected to operate in aquatic environments." said Gen. James F. Amos, Commandant of the Marine Corps, in Marine Corps Order 1500.52D, *in reference to the new swim qualifications.* 

"The old swim program was created and based on the needs of the battlefield in the 1940's during world War II. The needs of combat have changed, along with the gear as well. The program now has all the gear we use in combat. The fundamentals will remain the same, but the tasks the Marines execute will be more realistic to today's combat", said SSgt Nicholas Reyes, instructor of Water Survival, Camp Butler, Okinawa.."The new program is going to show Marines what to do if they fall into water with all of their gear on. It will also teach them how to strip their gear while in water and how to use their gear in order to save themselves as well as a fellow Marine. The program employs water survival skills of increasing levels of ability designed to reduce fear raise self-confidence and develop Marines with the ability to survive in water"

Subj:	Christmas SOP

Ref: (a) OPLAN 360-04 (North Pole) 1. Per the reference, an official staff visit by LtGen Claus is expected at your house on or about 25 DEC. The following instructions will govern the activities of ALCON during the visit.

a. Not a creature will stir without permission. This includes Warrant Officers ad mice. Marines may obtain special stirring permission for necessary administrative action through DPAC. Officer stirring permits must be obtained through the XO.

b. All personnel will settle their brains for a long winter nap NL T 2200, 24 DEC . Nap Uniform will be : Pajamas, Cotton, Light Weight, General Purpose. OK, and Watch Cap, Wool, Black. Equipment will be drawn from Supply prior to 2130. While at Supply, all personnel will review their ECR card and sign a checkage (DD Form 1131) for all missing items (remember, this is the "season of giving").

c. Personnel will utilize standard MRE sugar plums for visions to dance through their heads. MRE ration pack sugar plums should be eaten with egg loaf, chipped ham, and spice cake to ensure max visions are experienced.

d. Stockings, Wool, Cushion Sole, will be hung by the chimneys with care. Officers will conduct ZORM to ensure the necessary safety precautions are taken to avoid fires caused by carelessly hung stockings. Stocking handling plans will be submitted to the S-3 (Training) prior to 0830, 24 DEC.All SNCOs will ensure their subordinates are thoroughly briefed on the safety aspects of stocking hanging.

e. At the first sign of clatter, all personnel will spring from their beds to investigate and evaluate the cause. Immediate action will be taken to tear open the shutters and throw up the window sashes. On order, para 6-8 (c)(3) of the reference takes effect governing shutter tearing and sash throwing. SNCOs and NCOs will be familiar with procedures and are responsible for seeing that no shutters are torn or sashes thrown prior to the start of official clatter.

f. Prior to 0001, 25 DEC, all personnel possessing binoculars and night vision equipment will be assigned "wandering eyeball" stations.

g. The S-4 via the Motor Pool, will assign one (1) Sleigh, Miniature, M-24 and eight (8) reindeer, tiny, for use by LtGen Claus.

2. LtGen Claus will initially enter the CP via the CDO.

3. All SNCOs and NCOs will be rehearsed in the shouting of "Merry Christmas to All and to all a Good Night.".

### An Extraordinary Speech

What follows is a portion of a speech (condensed) given by LtGen John F. Kelly USMC on November 13, 2010 to the Semper Fi Society of Kansas City. What renders it so is that General Kelly's son First Lieutenant Robert Michael Kelly, was killed in action in Sangin, Afghanistan only four days before LtGen Kelly gave this speech. LtGen Kelly's eldest child is also a U.S. Marine. His speech ends with this: "I will leave you with a story about the kind of people they are (Marines)...about the quality of the steel in their backs...about the kind of dedication they bring to our country while they serve in uniform and forever after as veterans. Two years ago when I was the Commander of all U.S. and Iraqi forces, in fact, the 22nd of April 2008, two Marine infantry battalions, 1/9 "The Walking Dead," and 2/8 were switching out in Ramadi. One battalion in the closing days of their deployment going home very soon, the other just

starting its seven-month combat tour. Two Marines, Corporal Jonathan Yale and Lance Corporal Jordan Haerter, 22 and 20 years old respectively, one from each battalion, were assuming the watch together at the entrance gate of an outpost that contained a makeshift barracks housing 50 Marines. The same broken down ramshackle building was also home to 100 Iraqi police, also my men and our allies in the fight against the terrorists in Ramadi, a city until recently the most dangerous city on earth and owned by Al Qaeda. Yale was a dirt poor mixed-race kid from Virginia with a wife and daughter, and a mother and sister who lived with him and he supported as well. He did this on a yearly salary of less than \$23,000. Haerter, on the other hand, was a middle class, white kid from Long Island. They were from two completely different worlds. Had they not joined the Marines they would never have met each other, or understood that multiple Americas exist simultaneously depending on one's race, education level, economic status, and where you might have been born. But they were Marines, combat Marines, forged in the same crucible of Marine training and because of this bond they were brothers, as close, or closer than if they were born of the same woman.

Their orders were to stand the post and let no unauthorized personnel or vehicles pass. So they took up their post at the entry control point of Joint

Security Station Nasser, in the Sophia section of Ramadi, al Anbar, Iraq.

A few minutes later a large blue truck turned down the alley way - perhaps 60-70yards in length - and sped its way through the serpentine of concrete jersey walls. The truck stopped just short of where the two were posted and detonated, killing them both catastrophically. Twenty-four brick masonry houses were damaged or destroyed. A mosque 100 years away collapsed. The truck's engine came to rest 200 years away. The blast was made of 2,000 pounds of explosives. Two died, and because these two young infantrymen didn't have it in their DNA to run from danger, they saved 150 of their Iraqi and American brothers-in-arms.

A combat security camera recorded what happened. I traveled to Ramadi the next day and spoke individually to half dozen Iraqi police, all of whom told the same story. "We all knew immediately what was going on as soon as the two Marines began firing." To a

man they all ran for safety just prior to the explosion. Many were injured...some seriously. Putting myself in their head I supposed it took about a second for the two Marines to separately come to the same conclusion about what was going on once the truck came into their view at the far end of the alley. No time to talk it over. Only enough time to take half an instant to think about what the sergeant told them to do only a few minutes before." ... let no unauthorized personnel or vehicles pass." They presented their weapons, took aim and opened up. The recording show a number of Iragi police, some of whom had fired their AK's now scattering like the normal and rational men they were - some running right past the Marines. The recording shows the Marines weapons firing non-stop...the truck's windshield exploding into shards of glass as their rounds take it apart and tore in to the body of the son-of-a-bitch who is trying to get past them to kill their brothers and Marines bedded down in the barracks. IF they had been aware, they would have known they were safe...because two Marines stood between them and a crazed suicide bomber. The recording shows the truck careening to a stop immediately in front of the two Marines. In all of the instantaneous violence, Yale and Haerter never hesitated. They never stepped back. They never shifted their weight. With their feet spread apart, they leaned into the danger, firing as fast as they could work their weapons. The truck explodes. The camera goes blank. Two young men go to their God. That is the kind of people who are on watch all over the world tonight - for you."

## In the News

The "Soldiers of the Sea" have been fighting on land for a

decade in Iraq and Afghanistan. The Corps' amphibious troop carrier has just been canceled, its new fighter jet was postponed.

And the Marine Corps itself is finishing up its own review, asking this basic question: What should the Marine Corps look like in the 21st Century?

Going ashore in the face of hostile fire to claim a beach and push inland may be over. That's because Defense Secretary Robert Gates has done something pirates in the 19th century and Japanese troops in WWII couldn't do - he has the Marine Corps reeling.

There have been big cuts and delays in the Marine Corps budget are symbolic of a larger debate about the role of the Marine Corps in future warfare. Many potential adversaries have sophisticated long-range missiles that could strike the Marines in their landing craft long before they reach the shores. Defense Analyst Loren Thompson says that if the Marine Corps is no longer going to do opposed landing on enemy beaches in the face of hostile fire, then its role will be significantly diminished in the future. So now the relevance of the Marine Corps has come into question.

In their defense, Gen James Amos said recently they've been busier than ever. General Krulak said "the ability for Marines to float offshore and quickly respond offers any president a way to influence events. They can remain over the horizon, they can come on to the horizon and be seen and increase the pressure, or they can come ashore."

But Gates has suggested cutting their numbers - not just their weapons. Gates wants to reduce the Corps by some 15,000 to 20,000 in the coming years.

\*\*\*\*\*\*

Associated Press reports that a mock city roughly the size of downtown San Diego has risen in a remote Southern California desert to train military forces to fight in urban environments.

The \$170 million urban training center was unveiled in late January at the Twentynine Palms military base, 170 miles northeast of San Diego.

The 1,560 building facility will allow troops to practice and refine skills that can be used around the world, the Marine Corps said.

Seven separate mock city districts spread across 274 acres of desert. The fake markets, hotels and other businesses are complete with actors who create scenarios that pose a full range of challenges from humanitarian relief efforts to peacekeeping to police work and direct combat. More than 15,000 Marines and sailors can train simultaneously in the massive simulator.

Along with what they can plainly see, Marines in training will search for escape tunnels, hiding places, weapons caches and other dangerous spaces. The facility has almost 1,900 feet of underground tunnels, a manmade riverbed and dozens of courtyards and compounds.

Camp Pendleton has unveiled in November a \$30 million expansion of its mock Afghan village. In that facility, Marines scramble through a maze of mud walls leading to mosques, schools and carpet sellers, as Hollywood-style explosions go off.

Similar immersion training facilities are slated to open this year at Marine Corps bases in North Carolina, Hawaii and Okinawa.

### **BILL MAULDIN**

The Post Office gets a lot of criticism. Always has, always will. And with the renewed push to get rid of Saturday mail delivery, expect complaints to intensify. But the United States Postal Service deserves a standing ovation for something that happened last month: Bill Mauldin got his own postage stamp. **You have one on this issue of the Dispatch.** 

Mauldin died at age 81 in the early days of 2003. The end of his life had been rugged. He had been scalded in a bathtub, which led to terrible injuries and infections; and Alzheimer's disease was inflicting its cruelties. Unable to care for himself after the scalding, he became a resident of a California nursing home, his health and spirits in rapid decline. He was not forgotten, though. Mauldin, and his work, meant so much to the millions of Americans who fought in World War II, and to those who had waited for them to come home. He was a kid cartoonist for Stars and Stripes, the military newspaper; Mauldin's drawings of his muddy, exhausted, whiskerstubbled infantrymen Willie and Joe were the voice of truth about what it was like on the front lines.



Mauldin was an enlisted man just like the soldiers he drew for; his gripes were their gripes, his laughs their laughs, his heartaches, their heartaches. He was one of them. They loved him.

He never held back. sometimes when his cartoons cut too close for comfort, superior officers tried to tone him down. In one memorable incident, he enraged Gen. George S. Patton, who informed Mauldin he wanted the pointed cartoons celebrating the fighting men, lampooning the high-ranking officers, to stop. NOW! The news spread from soldier to soldier. How was Sgt Bill Mauldin going to stand up to Gen. Patton? It seemed impossible. Not quite. Mauldin, it turned out, had an ardent fan; fivestar Gen. Dwight D. Eisenhower, supreme commander of the Allied Forces in Europe. Ike put out the word: Mauldin draws what Mauldin wants. Mauldin won. Patton lost. Here is what, by the time he was 23 years old, Mauldin accomplished:

\*He won the Pulitzer Prize \*He was featured on the cover of Time Magazine.

\*His book "Up Front" was the No. 1 best-seller in the United States.

All of that at 23. Yet when he returned to civilian life and grew older, he never lost that boyish Mauldin grin, never outgrew his excitement about doing his job, never big-shotted or high-hatted the people with whom he worked every day.

Mauldin is buried in Arlington National Cemetery. Last month the kid cartoonist made it onto a firstclass postage stamp. It's an honor that most generals and admirals never receive.

Sea Stories

" I was serving with the Electronics Maintenance Company (ELMACO) 3rd FSR in 1976 at Camp Foster. There was a GySqt who had just arrived in the Company and was made the Company Gunny. We had had several thefts in the barracks at the time. In frustration with all the reports, the Company Gunny announced during a Monday morning formation that "any further reports of theft will result in Office Hours for the Marine who had items stolen." As an NCO and squad leader, I took several complaints from my squad as did the other squad leaders and Platoon Sergeants.

Several days went by with no reports of theft and the Gunny called a meeting of Squad Leaders and Platoon Sergeants. He wanted to let us know that he thought that this was the right thing to do to keep the reports down. We tried to reason with him that yes, reports are down because no one wants Office Hours for reporting a theft. He assured us that this was the way to go.

As we left the meeting we noticed that the Gunny had left his small car unlocked and in neutral. Several of us "relocated" the vehicle down in the Calibration area between the Cal and repair vans.

As we were forming up to march back to the barracks, he came out of his office to drive to the Staff NCO Quarters. The company milled about for a good 20 minutes before forming up to see what he would do. He walked around his building several times thinking he parked in a new location. When he couldn't find his car he left the area. We formed up and marched back to the barracks.

At the morning formation we were informed that the Gunny had located his car and was going to talk to the Cal Chief, MSqt Dan Cutcher, who was aware of the situation. Dan was a great mentor for me and many Marines in the Calibration field. He informed the Gunny that he had no idea how his vehicle had ended up wedged between the vans. No one noticed it when leaving the area the night before. With the Company First Sergeant present, Dan had asked if the Gunny had reported the car missing. He said "no, I found it." Dan recommended that the Gunny submit a report so an investigation could be conducted. When the Gunny kept refusing to submit a report, the First Sergeant then knew what was up.

At the following morning's formation the Company Gunny informed the Company that the person making a stolen items report would NOT go up for Office Hours. We were also instructed to check our areas when departing to look for anything that seemed out of place.

The thefts did finally end and two Marines who were in the Company were finally caught and brought to justice.

# This Month in History

**1 April 1945** - L Day for the 1st and 6th Marine Divisions on Okinawa.

**1976** - The MCSC Albany was redesignated Marine Corps Logistics Support Base Atlantic because the Marine Corps Supply Activity at Philadelphia was relocated to the Albany installation.

**6 April 1776** - Continental Marines in USS Alfred participated in the first naval engagement.

7 April 1958 - 8th and 6th Marines landed in Beirut, Lebanon.

**9 April 1953 -**Marines regained "Carson" Hill during fighting in Korea.

2003 - At about 1850 Cpl Edward Chin, 1st Tank Bn, tightened a chain around the neck of a statue of Saddam Hussein in Al-Firdos Square in the heart of Iraq's capitol and a Marine tank retriever pulled down the statue - Baghdad had been captured. 15 April 1962 - LtCol Archie Clapp and HMM 362 flew into Vietnam's Mekong Delta to set up operations at the Soc Trang airfield as part of Operation SHUFLY, thus becoming the first operational Marine Corps unit deployed to Vietnam.

**19 April 1995 -** Capt. Randolph A. Guzman and Sgt Benjamin L. Davis were killed when the Alfred Murrah Federal Office Building was bombed in Oklahoma City.

**25 April 1967 -** Khe Sanh "Hill fights" of 1967. 3rd Bn, 3rd Marines followed by 2/3 fought entrenched NVA on Hill 861 finally taking the hill three days later. Fighting continued through early May on Hill 881 as the 26th Marines came in to relieve the 3rd Marines. **30 April 1975 -** NVA captured Saigon; Vietnam War ended.

On 6 January 2011 SECNAV Robert Gates outlined an ambitious plan of cuts and efficiencies to squeeze more than \$78 billion in savings from the defense budget over five years. These initiatives include:

\* "modest" increases in fees for retirees under 65 and propose adjusting those fees every year at the rate of medical inflation. \*Reducing future Army and Marine Corps active duty forces - by 27,000 and 20,000-25,000 respectively starting in FY 2015. \* dramatic reductions in the number of DoD contractors (nearly 800 in TRI-CARE alone).

\*Elimination/downgrade of more than 100 general officer billets and 200 senior civilians.

\* Cancellation of the Marine Corps expeditionary fighting vehicle. \*consolidation of intelligence and information technology programs.

### REPORT FROM THE SE DIVISION CONFERENCE, 4 MARCH, 2011 ORLANDO, FLORIDA (CONDENSED)

\* Licensing of USMC trade Mark (Eagle, Glove and Anchor) The Marine Corps League has been granted permission to use the trademark (EGA) for internal use ONLY. NO permission is required for use on letter heads, business cards or announcements. If items are being developed for sale to the general public (caps, shirts, cups, jackets etc) permission is required and the developer MUST meet the requirements to use the Marine Corps trademark \* Chesty Puller Monument. The Marine Corps League is picking up the sponsorship of a monument of Chesty Puller at the new Marine Corps Museum memorial park. The monument will be at the very top of the park overlooking the rest of the park grounds. The cost is estimated at \$200k over the next 10 years. Marine Corps League BRICKs will be made available for placement around the monument at a cost of \$210 each. Should families wish to be grouped together, every attempt will be made to comply.

\* Department of the Navy and Marine Corps - is on hold due to the political climate.

#### \*National Judge Advocate

(Richard Gore): Conduct both financial and material audits of your Detachments and Departments. The League is bleeding money from officers walking off with money and materials. The Ceremonial Rifles are ON LOAN to your Detachments and MUST BE RETURNED if your Detachment surrenders its charter. The rifles MUST be held in a secure location (local Police, Sheriff, or National Guard Armory). DO NOT take rifles home.

### PTSD SYMPTOMS

Symptoms of PTSD include: \* Recurrent, intrusive and distressing thoughts about the event.

\* Recurrent dreams, nightmares about the event.

\* Flashbacks (a sense of reliving the event)

\* Distress caused by reminders of the event (sights, sounds, smells).

\*Alienation, isolation and avoidance of people and places.

\*Emotional numbing

\*Survivor guilt (for having survived when others did not, or for behavior required for survival)

\*Difficulty falling asleep or staying asleep

\*Anger and rage

\*Difficulty concentrating or remembering certain facts about the event

\*Hyper-vigilance, or survivalist behavior even after you are away from the event

\*Exaggerated startle responses (usually to loud noises)

These signs are NOT a sign of weakness or mental problems. There is help available from several sources including the VA.

# In the News

### JOPLIN TORNADO MARINE HERO

5/26/2011 Cpl David Rogers, 9th Marine Corps District (condensed)

SSgt Neville Shiwdin, a recruiter for Recruiting Substation Joplin, Recruiting Station Kansas City, struggled to hold closed the door to the closet in which he, his wife and kids took shelter inside his home as a tornado ripped through his home on May 22. After making sure that his family had water and blankets, he went outside to see where he could help.

Immediately he heard a woman screaming. She had left her children at home while she ran to the store for emergency supplies. While she was gone the tornado hit. The house was destroved and her children were missing. She was hysterical and began clawing at the debris of what was left of her home. looking for her children. SSgt Shiwdin began giving her aid and comfort and handed her over to some health workers.

He continued to search through his neighborhood and heard a child screaming. He pulled him from the rubble and saw that the bone was sticking out of his knee. He stopped an ambulance on its way to triage. It was packed with victims. They temporarily removed a less serious victim and put the boy in.

Shiwdin then thought about the senior gentleman who lived next door to him and went to his house. He found the man having a heart attack, but the man's family car was trapped

under a tree. Shiwdin's vehicle, which sustained some damage, was still working, so he found someone to take the man to triage.

Fifteen blocks away, Staff Sgt. Kenneth Thorson, a fellow recruiter, received a text from Shiwdin that his house was severely damaged. Thorson's family and home weren't disturbed by the storm. They got in their jeep and took off to find Shiwdin. When they arrived they put Shiwdin and his family in Shiwdin's other SUV and took them to their home. The next day the Marines of the RSS recovered anything vital from Shiwdin's home and began helping others in their community. They went to several triage centers including the one at Missouri Southern State University. They directed traffic and organized supplies. Other Marines from Kansas City arrived and helped patch the roof on another Marine recruiter's home.

Shiwdin received calls from Marines across the country. They are sending him care packages. He is also looking at renting a home in Thorson's neighborhood for his family. He continues without fear that the support of his fellow Marines will help his family recover.



We can see people just beyond the wire advancing toward it. I call the CO for permission to fire. Seconds later the Fifty Cal in the bunker opened fire spraying the fence line with a red hue that was chilling. After about 10 or 15 minutes it was all over. That morning, after daylight, we took a patrol out to the wire to see if we had caused any damage and what we needed to replace on the wire. There were four bodies on the wire of which one was our Battalion Barber. He had four gaping holes in his chest. This guy had been cutting our hair for almost 13 months and talking with us like we were his long lost buddies. Shows to go you, ya can't hardly trust anyone." submitted by Marine Bob Breton

Parris Island, the South Carolina military installation that has trained thousands of young Marines, has its first female commander. Brig. Gen. Bernadette Newman told CNN Savannah affiliate WSAV. "The Marine Corps gets it right. It's a performance-based society and if you look at General Reynolds's bio, she has more than enough experience to add value to this, so it is exciting." Reynolds recently returned from a year-long deployment to Afghanistan, where she was the first woman in the Marine Corps to command

units in a war zone. The 1st Marine Expeditionary Force Headquarters Group took a base that initially fed, housed and equipped more than 10,000 Marines, and built it up to handle the troop surge of an additional 10,000 Marines and sailors in Afghanistan, the Corps said.

I AM A DEVIL DOG By David Epps, Chaplain for the Clyde Thomason Detachment 1325, Coweta and Fayette Counties, GA. He is also Pastor of Christ the King Church. (printed by his permission)

Several weeks ago I became the holder of the degree of "D.D.". No, it's not an honorary doctorate, nor was it awarded by a church, university, or seminary. In fact, one cannot ever hope to possess this degree unless one holds an Honorable Discharge from the United States Marine Corps or has served as A Navy Corpsman to combat Marines.

I am a member of the Marine Corps League, a veteran's organization open only to active or honorably discharged Marines and Navy Corpsmen who served with the Fleet Marine Force. Once one is a member of the MCL, after about a year's service, one can be nominated for membership in The Military Order of the Devil Dogs, which has been described as the "fun and honor society" of the Marine Corps League.

While I cannot reveal the inner workings of the MODD, I will share that, for the first year of membership in the MODD, one is regulated to the lowly status of "pup". After that first full year, which I suppose is a bit like a probationary membership, one can attend the state MODD convention and there receive what is described as "the degree of Devil Dog." Which I did. And, so, I received the D.D. degree.

Most of the D.D. candidates, and there were fifteen, had some age on them. In fact, I may have been among the youngest of the group and I am 60 years old. When the fifteen "pups" were being sworn in as "Devil Dogs," they were asked to take an oath which included these words, "To protect and defend the Constitution of the United States of America against all enemies foreign and domestic..." All of the fifteen, and all those present at the convention, had taken a similar oath many years before upon entry into the Marine Corps.

Some of these men had seen battle in Korea, Vietnam, Beirut, in the Middle East, and in other violent places. Some in the room had fought their way across the Pacific to smash the Japanese Empire when they were young and strong. Now, a few in the room used canes and at least one use a wheelchair. But this much I knew; every person present - even those in their 60's, 70's and 80's would have no hesitation whatsoever taking up arms once again and fulfilling their oath if the need arose. Even among the grandfathers and great grandfathers, there was still the warrior spirit and the willingness to put their lives on the line once again, if the opportunity arose. It was a moment of clarity and solidarity that brought a lump to my throat.

Someone once asked me what was the proudest moment in my life. I have a few educational and athletic accomplishments, have received some accolades and recognition, but my answer was, "Graduation from Marine Corps boot camp at Parris Island, S.C." It was the day I became a Marine. That pride grew a bit a few weeks ago when I became a D.D. and realized that pride in God, Country, and corps is not only for the young and strong but for all those who are patriots at heart and are still willing to give the "last full measure of devotion," as Abraham Lincoln said in his Gettysburg Address. Whatever the age or cost, I have been, I am, and always will be a Devil Dog. Semper Fi."

## Sea Stories

Force Logistics Support Group Alpha (FLSG-A), DaNang, Vietnam 1966. In the middle of what some people think might have been one of the worst, if not the worst wars (politically anyway) for the United States, it is hard to believe that something comical could come from that environment. However, such is the case.

I had been "in country" a few months when we got word that a form of plague had broken out in Dog Patch, the village across the road from our compound, and that everyone would be required to take a Gamma Globulin (GG) shot. Now, if you are not familiar with Gamma Globulin it is administered in the hip area and the dosage is based on your weight. Being of a somewhat thick consistence, it is normally injected slowly so that the GG will spread evenly.

So, as I said, everyone reported to sick bay for their protection against the nasty plague from across the road. The process was simple. At this point let me state that it is always a good idea to be on good terms with the corpsmen in sick bay.

Well, there was a Marine behind me in line that was rather large and, for some reason, had a lot of not so pleasant words for the "swabbies" in sick bay. His turn for the GG came, he exposed his Gluteus Maximums and the corpsman administered the shot. The full quart (not sure how much but enough based on the Marine's weight and about twice the amount of my shot was injected in one swift push of the plunger. Needless to say what the results were. The Marine got the required GG injection and the corpsman got even for the unpleasant words. The Marine left sick bay with a noticeable limp and the knot on his rump the size of a goose egg did not go down for some time.

The moral of the story: do not irritate corpsmen while they are administering aid to you.

### This Month in History

<u>1 August 1944:</u> 2nd Force Service Support Group/2nd Marine Logistics Group activated as 8th Field Depot, Supply Service, FMF.

<u>2 August 1950:</u> The 1st Provisional Marine Brigade landed at Pusan, Korea, one month after being alerted. <u>6 August 1847:</u> LtCol S. E. Watson's Marines commenced their march on the "Halls of Montezuma" in Mexico. <u>7 August 1942:</u> The 1stMarDiv landed at Guadalcanal to open the WWII land offensive.

<u>13 August 1918:</u> Opha M. Johnson enlisted at HQMC becoming the first Woman Marine.

<u>14 August 1945:</u> V-J Day! President Harry Truman announced the unconditional surrender of the Japanese. <u>19 August 1919:</u> "The Marines Hymn" was registered with the U.S. Copyright Office.

<u>23 August 1798:</u> The first Headquarters of the Marine corps was established at *Philadelphia*.

<u>25 August 1948:</u> 2nd Lt John E. Rudder became the first black Marine officer commissioned in the regular Marine Corps.

<u>29 August 1916:</u> The Marine Corps Reserve was founded.

#### Sgt Reckless

Sqt. Reckless is an unsung hero of the Korean War and you should know about her. Reckless joined the Marines to carry ammunition to the front lines for the 75mm Recoilless Rifle Platoon of the 5th Marines - and she guickly earned the love and respect of all of the Marines that served with her. Lt. Eric Pederson paid \$250 of his own money to a young Korean boy, Kin Huk Moon, for her. You see, Sqt Reckless was a horse. It was not only Reckless' heroics that endeared the Marines to her - it was her incredible antics off of the battlefield. Reckless had a voracious appetite. She would eat anything and everything - but especially scrambled eggs and pancakes

in the morning with her morning cup of coffee. She also loved cake, Hershey bars, candy from the C rations, and Coca Cola even poker chips, blankets and hats when she was being ignored - or if she was trying to just prove a point.

One of Reckless' finest hours came during the Battle of Outpost Vegas in March of 1953. At the time of the battle it was written that, "The savagery of the battle for the so-called Nevada Complex has never been equaled in Marine Corps history." This particular battle, "was to bring a cannonading and bombing seldom experienced in warfare...twentyeight tons of bombs and hundreds of the largest shells turned the crest of Vegas into a smoking, death-pocked rubble." And Reckless was in the middle of all of it.

During the five-day battle, on one day alone she made 51 trips from the Ammunition Supply Point to the firing sites, 95% of the time alone by herself. She carried 386 rounds of ammunition (over 9,000 pounds - almost FIVE TONS! of ammunition) walked over 35 miles through open rice paddies and up steep mountains with enemy fire coming in at the rate of 500 rounds per minute. And as she so often did. she provided a shield for several Marines who were trapped trying to make their way up to the front lines. She was wounded twice, but that didn't stop or slow her down.

Her heroics defined the word "Marine." She was BELOVED by the Marines. They took care of her better than they took care of themselves - throwing their flak jackets over her to protect her when incoming was heavy, risking their own safety. Her Military Decorations included two Purple Hearts, Good conduct Medal, Presidential Unit Citation with star, National Defense Service Medal, Korean Service Medal, United Nations Service Medal, and Republic of Korea Presidential Unit Citation. all of which she wore proudly on her red and gold blanket.

Her highest rank held was SSgt awarded in 1959. She retired to the stables on Camp Pendleton and died 13 May 1968. She was buried on Camp Pendleton with full military honors.

I'd like to cover a few of the items with you that we discussed at the August meeting. First, the "Welcome Aboard" package has been given to a few of our new members. 1. To create a bond between old and new members so that new members feel more accepted into the Detachment. 2. Develop in new members a feeling

that they are a part of the Detachment. 3. Increase the retention rate and active participation of old and new members in the activities of the Detachment.

4. Encourage and increase open communication among the membership.

As a reminder to our new members, your mentor relationship will continue until you feel it is no longer needed.

Third, we will become a part of the MCLB TAP class starting in October. It is requested that we provide "Marines helping Marines" support in the area of job hunting. With the economic times we are experiencing, the Marines that are separating from active duty are searching for employment. What does that mean to us as a Detachment? In my opinion, it means that we can assist our fellow Marines by letting them know how to get in touch with a Detachment or Department from their home of record or wherever they plan to relocate. Our Detachment has participated in assisting separating Marines with finding jobs and locating housing here in the Albany area. Some have become members of the Detachment.

We are also a part of the "Welcome Aboard" brief every third Thursday of the month. For this brief, we will be making the new arrivals aware of the Marine Corps League and our Detachment. Both briefs are expected to be 5-10 minutes in length. Anyone wishing to assist in

developing these briefs please let me know.

Finally, we were approved by Department vote to submit a proposal to host the 2013 South East Division Conference. We will be meeting with the Merry Acres Inn Group to resolve a few details mentioned at the Staff Meeting. After that meeting, we will submit our proposal to Department Commandant Clark who will forward it to the Division National Vice Commandant Gardener and Division Marine Corps League Auxiliary National Vice President Lois Struthers-Payne. We are the only Detachment that will be submitting a proposal for the Conference. As with the 2009 Department Convention, we will be looking for volunteers to head up sub-committees and support duties for this conference. I will have more details at our September meeting.

## Marine of the Month

With this issue we are starting a column called "Marine of the Month". In it we will focus on one of our members with his/her picture and a short biography of what all has gone on in his/her life as a Marine, a family man or woman, and if retired, what the Marine has been doing with his life. Here is our first patriot.... Bill Hamby



Bill was born in 1928 in Calhoun County, MS. He joined the Marine Corps in 1945 and retired from the Engineer Field as a MGySqt from the MCLC in July 1969. His list of duty stations is impressive. He has served with the 1st, 2nd, 3rd and 4th Divisions. He had two tours at the Marine Corps Engineer School at Camp Lejeune. It is to be noted that Bill is a surviving member of the Chosen Few. He served in World War II, the Korean War and the Viet Nam War. Duty Stations to which he was assigned over the years include: Japan (twice), China, Camp Pendleton (5 times), Marine Barracks Memphis TN, I & I Portland, OR, Korea (evacuated 5 Dec 1950), Quantico, Camp Lejeune (three times), Philadelphia Supply Activity, Viet Nam (twice), HQMC, the State Dept, and Albany.

Bill went on after retirement to work as Senior Safety Engineer at the Firestone Corporation for 20 years and then worked with the support staff of Watson Spence Law Firm. He then started volunteering with the American Red Cross in Disaster Services in 1989 and has worked 87 disaster areas with them and is still serving.

He married Mollie in 1953 and they have 3 children and 5 grandchildren. Bill says that he wants the following on his epitaph:

#### He meant well

#### but didn't always do well.

Bill Hamby is an inspiration to us all and we are all proud that he is our brother in Detachment 1260.

## In the News

Removed from an ambushed platoon of Marines and soldiers in a remote Afghan village on 8 September 2009, his reality viciously shaken by an onslaught of enemy fighters, Marine Corps Cpl Dakota Meyer simply reacted as he knew best - tackling what he called "extraordinary circumstances" by doing the right thing whatever it takes."

Two years later, the President of the United States awarded the 23 year old Marine scout sniper from Columbia, KY the Congressional Medal of Honor. He is the first living Marine to receive this award in 38 years. Retired Sgt Major Allan Kellogg, Jr. received the medal in 1973.

Though bleeding from shrapnel wounds in his right arm, Meyer, aided by fellow Marines and Army advisors from Embedded Training Team 2-8, braved a vicious hail of enemy machine-gun and rocketpropelled grenade fire in the village of Ganigal to help rescue and evacuate more than 15 wounded Afghan soldiers and recover the bodies of four fallen U.S. fighters.

Meyer charged through the battle zone five times to recover the dead Marines and injured Afghan soldier, risking his life even when a medical evacuation helicopter wouldn't land because of the blazing gunfire.

Bing West, author of 'The Wrong War' praised Meyer for taking command of the battle as a corporal - the most junior advisor in this firefight. West said Meyer should have been killed, but he dominated the battlefield by fearlessly exposing himself to danger and pumping rifle and machine gun rounds into the enemy fighters.

In February 2009, Meyer volunteered to deploy to Afghanistan's dangerous Kunar province and mentor Afghan soldiers as part of an embedded training team, the type of role usually filled by U.S. Special Forces.

"Being a Marine - is a way of life." Meyer said. "It isn't just a word, and it's not just about the uniform - it's about brotherhood. Brotherhood means that when you turn around, they're there, through thick and thin. If you can't take care of your brothers, what can you do in life?"



# MGySgt Nick Retza



Nick was born in 1927 on Galveston Island, Texas. He enlisted in the Marine Corps in 1944 and retired from active duty in 1968 with the rank of MGySgt. He served with the 5<sup>th</sup>, 2<sup>nd</sup>, 1<sup>st</sup> and 3<sup>rd</sup> Marine Divisions over the years. During WWII he served with Recon, 28<sup>th</sup> Marines, 5<sup>th</sup> Marine Division in the Pacific and initial occupation of Japan. (He had gone through Scout/Sniper school at Camp Pendleton.)

He transferred to the 2<sup>nd</sup> Division in Japan when the 5<sup>th</sup> Division returned to CONUS to disband. Then, after a stint with the I&I, 14<sup>th</sup> Infantry Battalion, USMCR, in Houston, TX, he was transferred to the 1<sup>st</sup> Marine Division at Camp Pendleton. Because he was a Machinist Apprentice on the Southern Pacific Rail Road on weekends/summers during his high school years, he worked on locomotives and in machine shops operating lathes, boring mills and other machinery, he was assigned to the 1<sup>st</sup> Engineer Battalion. Over his protests, he was told the Division needed people that knew equipment and parts more than they needed scout/snipers. (That turned out to be the break of his USMC career although he yelled at the time. (His yells were tempered at the slop shoot at night. Engineers could drink well and he joined their ranks.)

After Winter Training in Alaska, the Korean War started and he sailed with the 1<sup>st</sup> Marine Division for the Inchon/Seoul Operation, and was at the Chosin (Chongjin) Reservoir when the Chinese Communists Forces (CCF) entered Korea to destroy the Marines and secure a Communist victory. Events went bad for the Chinese in these early days and although the 1<sup>st</sup> Marine Division evacuated North Korea, they moved south by sea to Pusan in tack with 98,000 North Korean Civilians who wanted to leave the Communist Territory. The CCF lost 42,000 killed in two weeks of "annihilating" the 1<sup>st</sup> Marine Division in the Chosin Campaign. (When he got to Hagaru North Korea at the Chosin Reservoir with engineer fortification gear (barbed wire, concertina wire, sand bags, etc) he had 14 Marines to unload about ten trucks and set up the camp, "Shaisa." Some Marine MP's came by us with about 25 Chinese Prisoners. He told the NCOIC that he needed them to unload the trucks for us at Hagaru. He said "They're yours." A Chinaman came up to Nick and bowed. He said, "Me know Marines, what you want." Nick said, "I want three tents set up and ten trucks unloaded (sand bags, barbed wire coils and concertina wire unloaded and stacked. Nick asked him "where he knew Marines? He snapped, "China" (like you, idiot, where else would I know them). Nick knew he was a "House Boy" for China Marines prior to WWII when China Marines were in China. When the tents and gear were set up, Nick and his Marines gave them some rations, Hershey Bars, and the MPs moved them down the road. (Strange things happen in war).

Events went bad for the Chinese in those early days of the Chosin Reservoir Campaign. (FYI, the "Chosin" name was Japanese from their occupation of Korea over the years. The real Korean name for the Reservoir is "Changjin". The Koreans have wanted us to change "Chosin Few" name but the group has refused. "Changjin Few" wouldn't sound as good.)

Home from Korea Nick was sent to the Supply Depot at Camp Lejeune for duty. After two years at Lejeune, LtCol Sherbondy told Nick he was transferring to Albany Georgia to help open a new Supply Depot and the Colonel was going with him.

Nick married Marilyn in 1952 at Lejeune and she and Nick moved to Albany, Georgia with their first baby daughter to continue their adventure. At Albany they had their second daughter and lived in Georgia for four years while at the Supply Depot..(Over the following years their family has grown to include two grandchildren and four greatgrandchildren, two of which are potential Marines.) Nic is a Texacan and Marilyn is a Yankee but the mix has worked out. Sometimes they use "sign language" with their parent families but they all get along.

After four years at Albany, Nick was transferred to HQMC for four more years. While in Washington he was assigned to get the Bulk Fuel Handling System on board, cataloged, and issued to the field. While on that assignment he was assigned to the IG team to travel to all bases to check out the progress of the Bulk Fuel Handling Systems.

After HQMC, Nick was sent to Okinawa with the Serviced BN, 3<sup>rd</sup> Marine Division. After Okinawa, he was transferred to the Marine Corps Supply Activity, Philadelphia, PA to help build a computerized Marine Corps supply system and after that was completed he retired and took a job in Nashua, New Hampshire and at night school received a Business Degree from UMass at Lowell, MA. Nick retired as a GS 13 from the Albany Supply Activity and became President of the Georgia Chapter of the Chosen Few.

And now, Nick is truly "retired" and says that he would do it all over again, even at the Chosen Reservoir.

# Retirees Pay Dates to Change

Military retirees and those who receive portions of retired pay are changing for September and December as the Defense Finance and Accounting Service changes its pay schedule to comply with the 2011 National Defense Authorization Act. The 2011 NDAA requires military retiree pay to be processed on the first day of the month. When that day falls on a weekend or national holiday, the pay date is moved to the previous business day. This year payments normally scheduled for October 3 will be issued on September 30 and payments normally scheduled for January 3, 2012 will be issued on December 30. For calendar 2011, this means military retirees will receive 13 rather than the normal 12 payments.

The 13th payday on December 30 falls within the 2011 tax year which could affect the tax liability of some retirees and those who receive portions of their retired pay. Customers should speak with a tax adviser, the Internal Revenue Service or their state tax authority to determine if their tax withholding will satisfy federal and state income taxes when they file returns next year. DFAS officials cannot provide tax advice. For tax year 2012 and beyond, retirees will receive their normal 12 payments.

Sea Stories

#### A story told by a friend:

In 1960 I was a senior Drill Instructor at San Diego Recruit Depot. The morning routine was for the DI's to awake before reveille. No recruits were permitted to be out of their Quonset Huts at that time.

One particular morning I and Sgt Black, the junior DI, were standing outside on the platoon street drinking coffee as daylight broke through. Sgt Black sighted something out of the corner of his eve (he the recon Marine). I heard him bellow, "Come here turd!" at this short, sulking figure in utilities buttoned at the top (as required of recruits). The figure rushed over to us and stood at rigid attention. Only then did Black and I recognize the figure as LT Gen Victor Krulak, Commanding Officer of the Recruit Depot (and father of the future 31st Commandant). Apparently the General's wandering was his covert observation of conditions to ensure his dictates were being followed. One of these policies was that recruits be addressed as "Private" and not by derogatory terms (a policy generally ignored by DIs, tradition not so easily dispensed with).

Sgt Black and I immediately knew we were in deep doo-doo. "How do you address recruits, Sergeants?" Without missing a beat, Sgt.Black, now at attention, answered, "Sir, 'Turd' is the acronym that stands for Trainee Undergoing Rigid Discipline." A moment of silence...then the General cracked a smile and ordered, "Very well, carry on." He then strolled off to another area.



Roger M. Paulin, MSgt USMC (Ret.) was born August 6, 1939 in Bristol, RI. He enlisted in the Marine Corps in February 1960 and graduated from MCRD Parris Island the same year. He was then transferred to HQ Co, Marine Corps Supply Depot, Albany, GA and served as Supply Chief. This is when he fell in love with Albany, GA. He made Corporal by July 1963. While on active duty, he completed an Associate Degree in Business from Mid-State College in Peoria, IL.

Roger's tenure in the Corps spanned over a period of 22 years and eight months. In December 1984 he was employed by the Marine Corps Logistics Base as an Inventory Management Specialist in the Weapons System Equipment Management Directorate. ### Chaplain's Corner

"He holds victory in store for the upright, He is a shield to those whose walk is

blameless•" (Proverbs 2:7)

God has a specific training ground for leaders. Marines are leaders, as are those who are His followers. There are three patterns of preparation that have been common among most of god's leaders. First, there is a time when the leader is separated from his old life (remember Boot Camp). In order for God to mold and shape them into His nature, it appears that He had to remove such men as Moses, Joseph, Abraham, and Paul from the life of comfort. A teacher once said, "You cannot go with God and remain where you are." Next, there is usually a time of solitude. God often brings leaders into a time of solitude in order to speak to them without other distractions. Paul was sent to Arabia for two years for a time of solitude. Joseph spent years in the solitude of prison. Moses spent 40 years in the desert herding sheep. The third characteristic of God's preparation for leaders is discomfort. The setting in which the preparation takes place usually is not a place of comfort (look back on some of your duty stations and assignments). David lived in caves fleeing Saul. Paul was frequently persecuted.

Are you ready for the classroom of leadership preparation? Some of you are about to be asked to take a position of leadership in the Detachment. You may have one of three reactions to this. First you may say, "**I don't need it.**" Perhaps you know intellectually that you do need this, but God wants you to know it in your heart. Pride prevents us from entering this classroom. The second reaction may be, "I'm tired of it." You decide you've had enough. If so, this will disqualify you from leadership. Finally, God's desired response from us is, "I accept it." To accept it with joy is the place of maturity in Christ.



## Member Spotlight



Dave Aldrich, is highlighted for you this month. Dave enlisted in the Marine Corps on 12 August 1960 in Albany, New York and reported to Marine Corps Recruit Depot, Parris Island, South Carolina on 26 September 1960. Upon completion of recruit training and advanced infantry training at Camp LeJeune in 1961, he was ordered to the First Marine Brigade, FMF, Kaneohe Bay, Hawaii; and subsequently transferred in 1964, as a Corporal, to the Marine Corps Supply Center, Albany, Georgia. In 1965, while stationed at Albany, he was

promoted to Sergeant, meritoriously, as the Center's Marine of the Quarter; transferred in 1968 to Third Force Service Regiment, Okinawa and as a Staff Sergeant, ordered to Force Logistics Command, Vietnam.

In 1969, Dave was selected and ordered to the Ninth Warrant Officers Candidate Course, promoted to Warrant Officer 1 and then reported to the Warrant Officer's Basic Course in June 1969. Upon completion of school, his next assignment was at MCRD Parris Island, South Carolina, as a Skivvy Scrubber (no, scratch that), OIC DSSC Depot Supply. ### This Month in History

In combat, during WWII, the holiday season situation often dictated minimal celebration. For example, on Guadalcanal at Christmas 1942, those with the Second Marine Division received a fresh orange and a warm can of beer to supplement their regular diet of C-rations.

A guy named Tom Williams served with the 5th Marine Division in 1944-45. Christmas 1944 found him at Camp Tarawa in Hawaii. This was his first holiday season away from his family in Southern California. He remembered, "Camp Tarawa was a lonely place that year. We didn't know what was going to happen to us and we were thinking a lot about our families." Alda Devine served with the 3rd MarDiv in 1943-44. For him and his buddies, the holidays were tough, even when surrounded by other Marines. He wrote (as found in BATTLE CRY by Leon Uris),

"Christmas services were held in a warehouse on Wellington docks. After singing carols, and sermons from Chaplain Peterson and Father McHale, we all came down with a bad case of the GI Blues. Andy, Danny, Marion, and the rest, all were quiet and remorseful. I wished the hell I could just wake up and find Christmas had come and gone. No one cared to talk, just sat around, lost to each other, and wrapped in their thoughts. Danny read an old letter. Marion had his wallet open looking longingly at the picture of the girl with red hair. Even Ski, with only bitter memories, studied the fading picture of Susan. Thinking was bad, it might wreck the operation. But what else could a man do on Christmas Eve?"

Did you know the saying "God willing and the Creeks don't rise" was in reference to the Creek Indians and not a body of water? If was written by Benjamin Hawkins in the late 18th century. He was a politician and Indian diplomat. While in the south, Hawkins was requested by the President of the U.S. to return to Washington. In his response, he was said to write, "God willing and the Creeks don't rise." Because he capitalized the word "Creeks" it is deduced that he was referring to the Creek Indian tribe and not a body of water.


